Motion was made by Mr. Stiers, which carried 3:2, to adopt the following ordinance:

**AN ORDINANCE TO REZONE APPROXIMATELY  
0.57 ACRES OF LAND FROM BUSINESS TO  
R-1, SINGLE FAMILY RESIDENTIAL**

WHEREAS, Larry Hitchcock has submitted a "Rezoning/Ordinance Change Application" dated February 1, 2017; and

WHEREAS, said application requests the rezoning of approximately 0.57 acres identified on the New Kent County digital map as GPIN #H09-4014-2795 (Tax Parcel 30-7); and

WHEREAS, subsequent to receiving a complete application and within the timeframes established by Code, on March 20, 2017 the Planning Commission scheduled and conducted a formal and duly advertised public hearing, carefully considering the public comment received; and

WHEREAS, the Planning Commission voted 5:1:1 to forward the application to the New Kent County Board of Supervisors with a favorable recommendation; and

WHEREAS, the rezoning application has been advertised for public hearing before the Board of Supervisors in full accord with applicable provisions of the Code of Virginia; and

WHEREAS, approval of the rezoning request through the adoption of this Ordinance will further the public necessity, convenience, general welfare and good zoning


practices in the County of New Kent; and

NOW THEREFORE BE IT ORDAINED this, the 10<sup>th</sup> day of April, 2017, by the New Kent County Board of Supervisors, that application ZM-01-17 be, and it hereby is, approved by amending the New Kent County Zoning Map to reclassify GPIN #H09-4014-2795 (Tax Parcel 30-7) as R-1, Single Family Residential.

BE IT FURTHER ORDAINED, that the County Administrator be, and he is hereby, directed to have a fully executed copy of this Ordinance recorded upon the Land Records of the County in the office of the Clerk of the Circuit Court.



