**AN ORDINANCE AMENDING APPENDIX A OF THE
NEW KENT COUNTY CODE (FEE SCHEDULE) TO CHANGE
CERTAIN FEES CHARGED FOR
COUNTY SERVICES (GENERAL GOVERNMENT FEES)
UNDER THE AUTHORITY GRANTED IN
THE CODE OF VIRGINIA**

WHEREAS, the County of New Kent imposes user fees for certain county services; and

WHEREAS, the costs of providing these services are greater than the fees presently charged; and

WHEREAS, fees must be increased so that taxpayers would not have to bear the costs of paying for these services.

**NOW THEREFORE UPON PUBLIC HEARING DULY HELD, BE IT
ORDAINED AND ENACTED**, by the New Kent County Board of Supervisors pursuant to the authority granted in the Code of Virginia, that the current Appendix A Fees be amended as follows:


