Motion was made by Mr. Evelyn, which carried 5:0, to adopt the following ordinance:

**AN ORDINANCE APPROVING APPLICATION AFD-002-17
FOR THE RE-CREATION OF THE
BLACK CREEK AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, The Black Creek Agricultural and Forestal District was established August 9, 2010 for a ten-year term and currently contains 1,687 acres, of which 1,559 identified acres are being proposed (parcels marked with *** are not renewing); and

WHEREAS, The Black Creek Agricultural and Forestal District term expires August 31, 2017 and all the current members have indicated that they wish to renew their membership in the district except tax map parcel 9-29 and tax map parcel 10-48; and

WHEREAS, The Black Creek Agricultural and Forestal District currently consists of the following parcels:

WHEREAS, the re-creation of this district was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and


WHEREAS, after conducting a duly advertised public meeting on the 20th day of April, 2017, the Agricultural and Forestal District Advisory Committee voted 6:0:0 to forward a favorable recommendation to the Planning Commission; and

WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on May 15, 2017 in accordance with the applicable requirements of the Code of Virginia, carefully considered the public comments received and voted 9:0:1 to forward a favorable recommendation.

NOW THEREFORE BE IT ORDAINED this the 5th day of June, 2017, by the New Kent County Board of Supervisors, pursuant to Section 15.2-4311 of the Code of Virginia, the proposed Agricultural and Forestal District Application for the re-creation of the Black Creek Agricultural and Forestal District (with exception of tax map parcels 9-29 and 10-48 which will be allowed to expire on August 31, 2017) for a term of ten years is hereby approved.
