Motion was made by Mr. Tiller, which carried 5:0, to adopt the following ordinance:

AN ORDINANCE APPROVING APPLICATIONS AFD-003-17, AFD-004-17 AND AFD-005-17 FOR THE ADDITION OF TAX MAP PARCELS 25-41, 25-41A AND 25-41B TO THE COOKS MILL AGRICULTURAL AND FORESTAL DISTRICT

WHEREAS, Jonathan C. Kinney, Trustee, James L. Saunders has applied to add tax map parcels 25-41, 25-41A and 25-41B, totaling approximately 604 acres, of which 604 acres have been identified as agriculturally significant to the Cooks Mill Agricultural and Forestal District; and

WHEREAS, granting this request will increase the acreage of the Cooks Mill Agricultural and Forestal District from its current 4,588 acres; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and


WHEREAS, the Cooks Mill Agricultural and Forestal District will expire on August 31, 2026; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and


WHEREAS, after conducting a duly advertised public meeting on the 20th day of April, 2017, the Agricultural and Forestal District Advisory Committee voted 6:0:0 to forward a favorable recommendation to the Planning Commission; and

WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on May 15, 2017 in accordance with the applicable requirements of the Code of Virginia, carefully considered the public comments received and voted 9:0:1 to forward a favorable recommendation.

NOW THEREFORE BE IT ORDAINED this the 5th day of June, 2017, by the New Kent County Board of Supervisors, pursuant to Section 15.2-4310 of the Code of Virginia, the proposed Agricultural and Forestal District Application for the addition of tax map parcels 25-41, 25-41A and 25-41B containing approximately 604 acres to the Cooks Mill Agricultural and Forestal District is hereby approved.
