**AN ORDINANCE APPROVING APPLICATION AFD-006-17
FOR THE RE-CREATION OF THE
CRUMPS SWAMP AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, The Crumps Swamp Agricultural and Forestal District was established August 9, 2010 for a ten-year term and currently contains 646 acres, of which 646 identified acres are being proposed; and

WHEREAS, The Crumps Swamp Agricultural and Forestal District term expires August 31, 2017 and all the current members have indicated that they wish to renew their membership in the district; and

WHEREAS, the re-creation of this district was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and


