Motion was made by Ms. Paige, which carried 5:0, to adopt the following ordinance:

**AN ORDINANCE APPROVING APPLICATION AFD-011-17 FOR THE ADDITION OF  
TAX MAP PARCEL 41-32 TO THE SCHIMINOE CREEK AGRICULTURAL AND  
FORESTAL DISTRICT**

WHEREAS, John G. Powers has applied to add tax map parcel 41-32, totaling approximately 49 acres, of which 49 acres have been identified as agriculturally significant to the Schiminoe Creek Agricultural and Forestal District; and

WHEREAS, granting this request will increase the acreage of the Schiminoe Creek Agricultural and Forestal District from its current 3,671 acres; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and

WHEREAS, the Schiminoe Creek Agricultural and Forestal District term is set to be re-created on August 31, 2017; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public meeting on the 20<sup>th</sup> day of April, 2017, the Agricultural and Forestal District Advisory Committee voted 6:0:0 to forward a favorable recommendation to the Planning Commission; and


WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on May 15, 2017 in accordance with the applicable requirements of the Code of Virginia, carefully considered the public comments received and voted 9:0:1 to forward a favorable recommendation.

NOW THEREFORE BE IT ORDAINED this the 5<sup>th</sup> day of June, 2017, by the New Kent County Board of Supervisors, pursuant to Section 15.2-4310 of the Code of Virginia, the proposed Agricultural and Forestal District Application for the addition of tax map parcel 41-32 containing approximately 49 acres to the Schiminoe Creek Agricultural and Forestal District is hereby approved.
