WHEREAS, the representative for the Virginia Department of Transportation has advised this Board that the streets within **Patriots Landing Commercial – Phase One** meet the requirements established by the Virginia Department of Transportation's Subdivision Street Requirements;



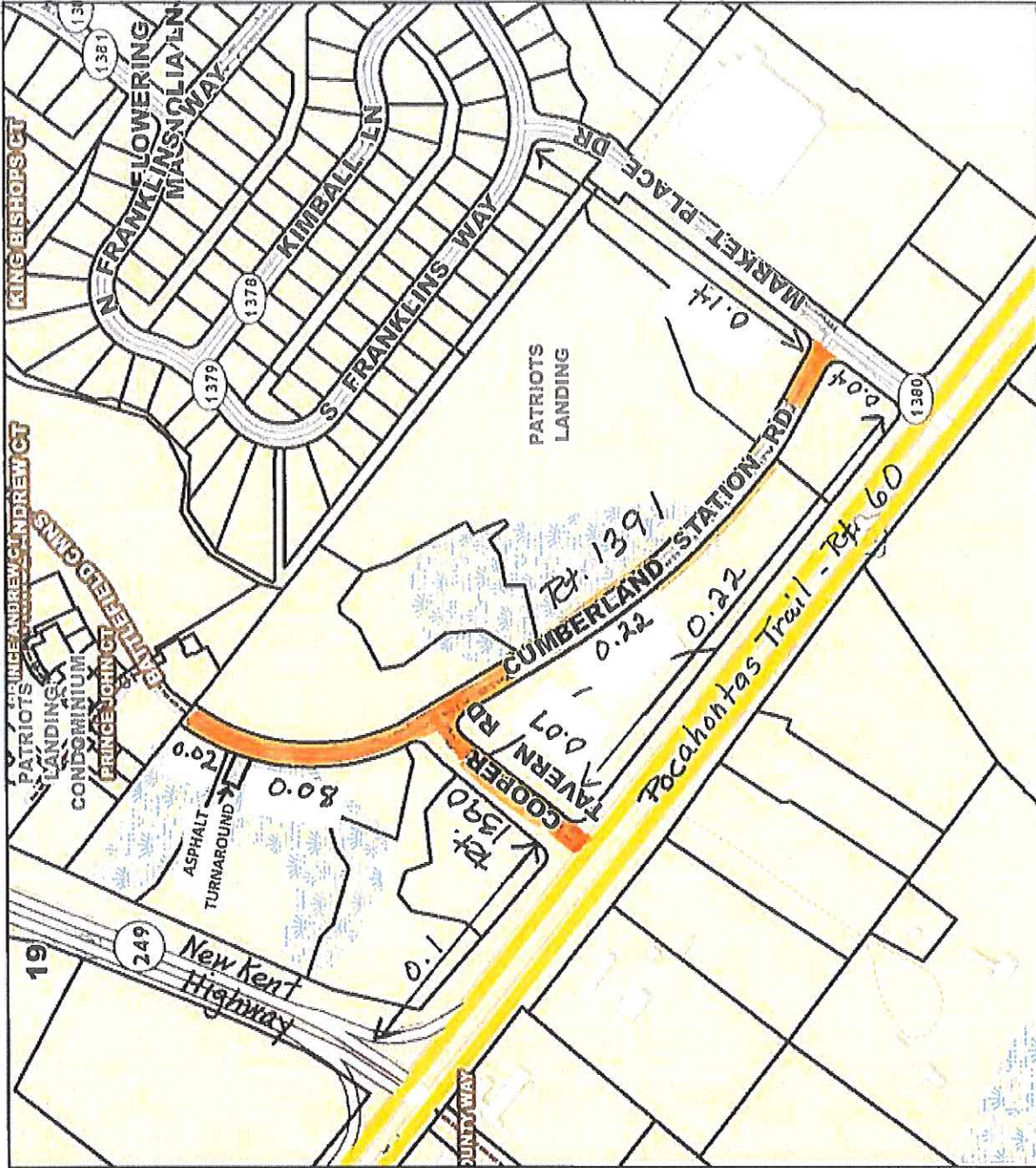
