


**WHEREAS**, Section 91-5 of the New Kent County Code defines the subdivision agent as the Director of Planning; and

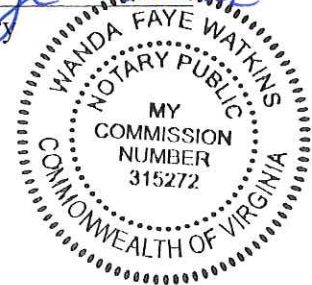
