### **IN RE: OFFICER ELECTIONS**

Mr. Gerald Simpson, Resource Officer, at the High School was the coordinator of the program and had spoken with Mrs. Carey and invited the Clean County Committee to attend the event on May 3, as well as attend a planning meeting at the High School on April 10<sup>th</sup>.
