**AN ORDINANCE APPROVING APPLICATION AFD-01-18
FOR THE RE-CREATION OF THE
LOWER CHICKAHOMINY AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, The Lower Chickahominy Agricultural and Forestal District was established August 9, 2010 for an eight-year term and currently contains 7 parcels totaling approximately 681 acres, and

WHEREAS, The Lower Chickahominy Agricultural and Forestal District term expires August 31, 2018 and all the current members have indicated they wish to renew their membership in the district, and

WHEREAS, the re-creation of this district was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and


