**A. Application ZM-03-18, New Kent Ordinary (Jonathan Kinney):** Mr. Jonathan Kinney has requested the rezoning from R-2 to Courthouse Development District of approximately 15.8 acres of land and the rezoning from A-1 to Courthouse Development District of approximately 2.17 acres of land. The subject properties are located at 12000 and 12010 New Kent Highway, and approximately 1500 feet to the east of 12010 New Kent Highway. The R-2 parcels are identified as Tax Parcels 24-17A (GPIN K20-2147-2257), 24-17B (GPIN K20-2277-2445), and 24-17 (GPIN K20-3057-2165). The A-1 parcel is identified as Tax Parcel 24-8-5-1 (GPIN K20-3836-1878). The proposal for the Ordinary ideally involves converting it to a mixed-use building. The properties are designated as Village on the Comprehensive Plan's Future Land Use Map.

**B. ~~APPLICATION HAS BEEN WITHDRAWN~~ Application CUP-02-18, Curtis Readiness Training Center:** ~~Representatives from Curtis Security Consulting, Inc. have requested a Conditional Use Permit to construct a tactical driving and training facility on property located at 4401 Barham Road, in Barhamsville. Curtis Security Consulting, Inc. is a small woman owned business specializing in training government, military, law enforcement and private corporations' personnel in three major skill areas - Counterterrorism/Force Protection~~

~~Operations, Driver Skills, and Firearm Skills. The proposed site would contain an asphalt driver training course, an off road and unimproved road driving course, and a vehicle maintenance shop area to service the driving courses. Also proposed are four 100 meter multipurpose ranges and one 300-meter qualification range. In the proposed shooting range area would be storage structures for the armory, self contained "Simunition®" training areas, and a ballistic shoot house. The subject property is identified as Tax Parcel 37-65 (GPIN G310-0352-0885). The property is designated as Hamlet and Rural Lands on the Comprehensive Plan's Future Land Use Map.~~
