WHEREAS, The Cattail Swamp Agricultural and Forestal District was established August 8, 2010 for a nine-year term and currently contains 14 parcels totaling approximately 774.77 acres, and

WHEREAS, The Cattail Swamp Agricultural and Forestal District term expires August 31, 2019 and all the current members have indicated they wish to renew their membership in the district, and


WHEREAS, the re-creation of this district was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and
