Motion was made by Mr. Evelyn, which carried 4:0:1, to adopt the following ordinance:

**AN ORDINANCE APPROVING APPLICATION AFD-02-19 FOR THE ADDITION OF  
TAX MAP PARCELS 26-30 AND 26-119 TO THE COOKS MILL AGRICULTURAL  
AND FORESTAL DISTRICT**

WHEREAS, Marilyn M. and Monty R. Mills have applied to add tax map parcels 26-30 and 26-119 totaling approximately 113.80 acres to the Cooks Mill Agricultural and Forestal District; and

WHEREAS, granting this request will increase the acreage of the Cooks Mill Agricultural and Forestal District from its current 5,173.16 acres; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and

WHEREAS, the Cooks Mill Agricultural and Forestal District is set to expire August 31, 2026; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public meeting on the 16th day of May, 2019, the Agricultural and Forestal District Advisory Committee voted 7:0:0 to forward a favorable recommendation to the Planning Commission; and


WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on June 17, 2019 in accordance with the applicable requirements of the Code of Virginia, carefully considered the public comments received and voted 9:0:1 to forward a favorable recommendation.

NOW THEREFORE BE IT ORDAINED this the 8th day of July, 2019, by the New Kent County Board of Supervisors, pursuant to Section 15.2-4310 of the Code of Virginia, the proposed Agricultural and Forestal District Application for the addition of tax map parcel 26-30, GPIN J26-3155-3374 and tax map parcel 26-119, GPIN J27-1120-4300, containing approximately 113.8 acres to the Cooks Mill Agricultural and Forestal District is hereby approved.
