**AN ORDINANCE APPROVING APPLICATION AFD-04-19
FOR THE RE-CREATION OF THE
HOLTS CREEK AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, The Holts Creek Agricultural and Forestal District was established August 8, 2010 for a nine-year term and currently contains 3 parcels totaling approximately 1,026.76 acres, and

WHEREAS, The Holts Creek Agricultural and Forestal District term expires August 31, 2019 and all the current members have indicated they wish to renew their membership in the district, and

WHEREAS, The Holts Creek Agricultural and Forestal District currently consists of the following parcels:



WHEREAS, the re-creation of this district was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and


WHEREAS, after conducting a duly advertised public meeting on the 16th day of May, 2019, the Agricultural and Forestal District Advisory Committee voted 7:0:0 to forward a favorable recommendation to the Planning Commission; and

WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on June 17, 2019 in accordance with the applicable requirements of the Code of Virginia, carefully considered the public comments received and voted 8:1:1 to forward a favorable recommendation with the exception of tax map parcel 24-35A, GPIN L20-3287-4013.

NOW THEREFORE BE IT ORDAINED this the 8th day of July, 2019, by the New Kent County Board of Supervisors, pursuant to Section 15.2-4311 of the Code of Virginia, the proposed Agricultural and Forestal District Application for the re-creation of the Holts Creek Agricultural and Forestal District, with the exception of Tax Map parcel 24 35A, for a term of ten years is hereby approved.
