Motion was made by Mr. Davis, which carried 5:0, to adopt the following ordinance:

**AN ORDINANCE APPROVING APPLICATION AFD-05-19 FOR THE ADDITION OF
TAX MAP PARCELS 22-31, 22-47 AND 22-30 TO THE PELHAM SWAMP
AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, Margie P. Harrison has applied to add tax map parcels 22-31, 22-47 and 22-30 totaling approximately 334.82 acres to the Pelham Swamp Agricultural and Forestal District; and

WHEREAS, granting this request will increase the acreage of the Pelham Swamp Agricultural and Forestal District from its current 2,466 acres; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and

WHEREAS, the Pelham Swamp Agricultural and Forestal District is set to expire August 31, 2025; and


WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public meeting on the 16th day of May, 2019, the Agricultural and Forestal District Advisory Committee voted 7:0:0 to forward a favorable recommendation to the Planning Commission for tax map parcels 22-31 and 22-47 and


voted 7:0:0 to forward an unfavorable recommendation to the Planning Commission for tax map parcel 22-30; and

WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on June 17, 2019 in accordance with the applicable requirements of the Code of Virginia, carefully considered the public comments received and voted 9:0:1 to forward a favorable recommendation of tax map parcels 22-31 and 22-47 and voted 9:0:1 to forward an unfavorable recommendation of tax map parcel 22-30.

NOW THEREFORE BE IT ORDAINED this the 8th day of July, 2019, by the New Kent County Board of Supervisors, pursuant to Section 15.2-4310 of the Code of Virginia, the proposed Agricultural and Forestal District Application for the addition of tax map parcel 22-31, GPIN L14-1299-1755 and parcel 22-47, GPIN L14-2400-2912 containing approximately 211.42 acres to the Pelham Swamp Agricultural and Forestal District is hereby approved.
