Motion was made by Mr. Davis, which carried 5:0, to adopt the following ordinance:

**AN ORDINANCE APPROVING APPLICATION AFD-11-19 TO WITHDRAW TAX  
MAP PARCEL 37-18A FROM THE MILL CREEK  
AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, Rebecca L. & Timothy K. Salavejus have applied to withdraw tax map parcel 37-18A, GPIN I29-3654-1502, totaling approximately 11 acres, from the Mill Creek Agricultural and Forestal District; and

WHEREAS, the Mill Creek Agricultural and Forestal District was established August 9, 2010 and is set to expire on August 31, 2028, and contains approximately 1,520 acres, of which, 11 acres are requested for withdrawal from the district; and


WHEREAS, the withdrawal of the 11 acres from the district was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public meeting on July 18, 2019, the Agricultural and Forest District Advisory Committee voted 6:0:0 with a favorable recommendation to approve this application to withdraw; and

WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on August 19, 2019 in accordance with the applicable requirements of the Code of Virginia, carefully considering the public comments received and voted 8:0:1 to forward a favorable recommendation.


NOW THEREFORE BE IT ORDAINED, that on this, the 3<sup>rd</sup> day of September, 2019, pursuant to Section 15.2-4314 of the Code of Virginia, the New Kent County Board of Supervisors approves the withdrawal of 11 acres of land from tax map parcel 37-18A, GPIN I29-3654-1502 within the Mill Creek Agricultural and Forestal District; and, pursuant to Section 58.1-3237 of the Code of Virginia, the New Kent County Board of Supervisors authorizes the Commissioner of Revenue to collect any and all roll-back taxes associated with this withdrawal effective upon the date of adoption.
