Motion was made by Mr. Lockwood, which carried 5:0, to adopt the following ordinance:

**AN ORDINANCE APPROVING APPLICATION AFD-05-20 TO DEFER RE-
CREATION OF YORK RIVER AGRICULTURAL AND FORESTAL DISTRICT DUE
TO BOARD MORATORIUM R-23-20**

WHEREAS, all the members of the York River Agricultural and Forestal District have applied to re-create the said district, consisting of 53 parcels totaling approximately 2,897.98 acres; and

WHEREAS, granting this request would defer the re-creation of the York River Agricultural and Forestal District per the objective of the New Kent County Board of Supervisors; and

WHEREAS, this request is in accordance with the New Kent County Board of Supervisors moratorium resolution R-23-20 as well as state and local laws governing Agricultural and Forestal Districts; and

WHEREAS, the York River Agricultural and Forestal District term that was set to expire on August 31, 2020 would be extended one year to August 31, 2021; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and


WHEREAS, after conducting a duly advertised public meeting on the 1st day of December, 2020, the Agricultural and Forestal District Advisory Committee voted 7:0:0 to forward a favorable recommendation to the Planning Commission to defer; and

WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on December 21, 2020 in accordance with the applicable requirements of the Code of Virginia, carefully considering the public comments received; and


WHEREAS, the Planning Commission carefully reviewed the application and the recommendation of the Agricultural and Forestal District Advisory Committee and considered the goals and objectives of the County's Comprehensive Plan as well as resolution R-23-20 and voted 7:0:1 to forward a favorable recommendation to defer.

NOW THEREFORE BE IT ORDAINED, that on this, the 12th day of January, 2021, pursuant to Section 15.2-4311 of the Code of Virginia, the New Kent County Board of Supervisors approves the deferral of the re-creation of the York River Agricultural and Forestal District and extends the expiration date one year from August 31, 2020 to August 31, 2021.
