Motion was made by Ms. Paige, which carried 5:0, to adopt the following ordinance:

**AN ORDINANCE APPROVING APPLICATION AFD-04-21 FOR THE ADDITION OF  
TAX MAP PARCEL 3-19, GPIN P10-1727-1926 AND TAX MAP PARCEL 3-19A, GPIN  
P10-1219-1668 TO THE PUTNEY CREEK AGRICULTURAL AND FORESTAL  
DISTRICT**

WHEREAS, Christina and Steven J. Berta have applied to add tax map parcel 3-19 and tax map parcel 3-19A, totaling approximately 83.85 acres, to the Putney Creek Agricultural and Forestal District; and

WHEREAS, granting this request will increase the acreage of the Putney Creek Agricultural and Forestal District from its current 3,015.31 acres; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and


WHEREAS, the Putney Creek Agricultural and Forestal District is set to expire August 31, 2025; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public meeting on the 14th day of May, 2021, the Agricultural and Forestal District Advisory Committee voted 5:0:0 to forward a favorable recommendation to the Planning Commission; and


WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on June 21, 2021 in accordance with the applicable requirements of the Code of Virginia, carefully considered the public comments received and voted 8:0:0 to forward a favorable recommendation.

NOW THEREFORE BE IT ORDAINED this the 12th day of July, 2021, by the New Kent County Board of Supervisors, pursuant to Section 15.2-4310 of the Code of Virginia, the proposed Agricultural and Forestal District Application for the addition of tax map parcel 3-19, GPIN P10-1727-1926 and tax map parcel 3-19A, GPIN P10-1219-1668, containing 83.85 acres to the Putney Creek Agricultural and Forestal District is hereby approved.
