Motion was made by Ms. Paige, which carried 5:0, to adopt the following ordinance:

**AN ORDINANCE APPROVING APPLICATION AFD-11-21 TO WITHDRAW TAX
MAP PARCEL 36-41, GPIN I27-3208-3274 FROM THE WAHRANI SWAMP
AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, Barbara J. & Joseph Stanko have applied to withdraw tax map parcel 36-41, GPIN I27-3208-3274, containing approximately 61.51 acres, from the Wahrani Swamp Agricultural and Forestal District; and

WHEREAS, the Wahrani Swamp Agricultural and Forestal District was established August 9, 2010, renewed August 31, 2019 and is set to expire on August 31, 2029, and contains approximately 1,481.65 acres, of which, 61.51 acres are requested for withdrawal from the district; and


WHEREAS, the withdrawal of the 61.51 acres from the district was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public meeting on December 16, 2021, the Agricultural and Forest District Advisory Committee voted 7:0:0 with a favorable recommendation to approve this application for withdrawal; and


WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on January 18, 2022 in accordance with the applicable requirements of the Code of Virginia, carefully considering the public comments received and voted 9:0:1 to forward a favorable recommendation to withdraw.

NOW THEREFORE BE IT ORDAINED, that on this, the 14th day of February, 2022, pursuant to Section 15.2-4314 of the Code of Virginia, the New Kent County Board of Supervisors approves the withdrawal of tax map parcel 36-41, GPIN I27-3208-3274, consisting of approximately 61.51 acres, from the Wahrani Swamp Agricultural and Forestal District and authorizes the collection of any applicable roll-back taxes associated with this withdrawal by the Commissioner of Revenue effective upon the date of adoption.
