Motion was made by Mr. Lockwood, which carried 5:0, to adopt the following ordinance:

**AN ORDINANCE APPROVING APPLICATION AFD-02-22  
FOR THE ADDITION OF TAX MAP PARCELS 43-68, GPIN D20-0134-3650  
AND 43-69, GPIN D19-2828-4119 TO THE LOWER CHICKAHOMINY  
AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, Lindsay Arboretum & Game Preserve has applied to add tax map parcel 43-68, GPIN D20-0134-3650 and 43-69, GPIN D19-2828-4119, totaling approximately 80 acres to the Lower Chickahominy Agricultural and Forestal District; and

WHEREAS, granting this request will increase the acreage of the Lower Chickahominy Agricultural and Forestal District from its current 723.42 acres; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and

WHEREAS, the Lower Chickahominy Agricultural and Forestal District is set to expire August 31, 2028; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public meeting on the 19th day of May, 2022, the Agricultural and Forestal District Advisory Committee voted 7:0:0 to forward a favorable recommendation to the Planning Commission; and


WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on June 21, 2022 in accordance with the applicable requirements of the Code of Virginia, carefully considered the public comments received and voted 8:0:2 to forward a favorable recommendation.

NOW THEREFORE BE IT ORDAINED this the 11th day of July, 2022, by the New Kent County Board of Supervisors, pursuant to Section 15.2-4310 of the Code of Virginia, the proposed Agricultural and Forestal District Application for the addition of tax map parcel 43-68, GPIN D20-0134-3650 and 43-69, GPIN D19-2828-4119, containing approximately 80 acres to the Lower Chickahominy Agricultural and Forestal District is hereby approved.
