Motion was made by Mr. Lockwood, which carried 5:0, to adopt the following ordinance:

**AN ORDINANCE APPROVING APPLICATION AFD-05-22
TO WITHDRAW TAX MAP PARCELS 38-17, GPIN H31-3173-3534;
38-18, GPIN H31-3518-3760 AND 38-19, GPIN H31-3256-2797
FROM THE YORK RIVER AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, Lloyd C. Davis has applied to withdraw tax map parcels 38-17, GPIN H31-3173-3534, 38-18, GPIN H31-3518-3760 and 38-19, GPIN H31-3256-2797, containing approximately 57.58 acres, from the York River Agricultural and Forestal District; and

WHEREAS, the York River Agricultural and Forestal District was established August 9, 2010, renewed August 31, 2021 and is set to expire on August 31, 2031, and contains approximately 2,840.40 acres, of which, 57.58 acres are requested for withdrawal from the district; and

WHEREAS, the withdrawal of the 57.58 acres from the district was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public meeting on May 19, 2022, the Agricultural and Forest District Advisory Committee voted 6:0:1 with a favorable recommendation to approve this application to withdraw; and

WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on June 21, 2022 in accordance with the applicable requirements of the Code of Virginia, carefully considering the public comments received and voted 8:0:2 to forward a favorable recommendation to withdraw.

NOW THEREFORE BE IT ORDAINED, that on this, the 11th day of July, 2022, pursuant to Section 15.2-4314 of the Code of Virginia, the New Kent County Board of Supervisors approves the withdrawal of tax map parcels 38-17, GPIN H31-3173-3534; 38-18, GPIN H31-3518-3760 and 38-19, GPIN H31-3256-2797, consisting of approximately 57.58 acres, from the York River Agricultural and Forestal District and authorizes the collection of any applicable roll-back taxes associated with this withdrawal by the Commissioner of Revenue effective upon the date of adoption.
