**AN ORDINANCE AMENDING APPENDIX A OF THE
NEW KENT COUNTY CODE (FEE SCHEDULE) TO CHANGE
CERTAIN FEES CHARGED FOR COUNTY SERVICES
UNDER THE AUTHORITY GRANTED IN
THE CODE OF VIRGINIA**

WHEREAS, the County of New Kent imposes user fees for certain county services; and

WHEREAS, the costs of providing some of these services are greater or less than the fees presently charged; and

WHEREAS, some fees must be increased so that taxpayers would not have to bear the costs of paying for these services; and

WHEREAS, some fees must be decreased so that taxpayers will not be paying more than the actual costs of providing these services.


**NOW THEREFORE UPON PUBLIC HEARINGS DULY HELD, BE IT


