**AN ORDINANCE AMENDING APPENDIX A OF THE
NEW KENT COUNTY CODE (FEE SCHEDULE) TO
CHANGE CERTAIN FEES CHARGED FOR COUNTY SERVICES
UNDER THE AUTHORITY GRANTED IN
§§ 15.2-2286 AND 36-105 OF THE CODE OF VIRGINIA**

WHEREAS, the County of New Kent imposes user fees for certain county services; and

WHEREAS, the costs providing these services is greater than the fees presently charged; and

WHEREAS, the costs for these services must be increased so that taxpayers would not have to bear the costs of paying for these services.

NOW THEREFORE UPON PUBLIC HEARING DULY HAD, BE IT ORDAINED AND ENACTED by the New Kent County Board of Supervisors pursuant to the authority granted in §§ 15.2-2286 and 36-105 of the Code of Virginia, that the following fees shall be imposed:
