Public Hearings will be held at 7:00 p.m. or as soon thereafter as possible. Speakers are limited to three minutes each, and should come to the podium and state their name and address.

- A. CUP-02-10, Clear Signal Towers (Christian): Clear Signal Towers, LLC and Lawrence E. Christian have requested a conditional use permit for the purpose of installing a cell tower. Pursuant to Section 98-62 of the New Kent County Code, the "Communications Facility Tower - Radio, Cellular < 200 feet" use is allowed with a conditional use permit under the A-1, Agricultural zoning classification. The proposed site is located at 3361 Quaker Road (Rt. 611). The property is identified on the New Kent County tax map as parcel number 19-15, and the digital map as GPIN L06-2175-5286. The property is designated as Suburban Housing Detached on the Comprehensive Plan's Vision 2020 Future Land Use Map.
- B. CUP-03-10, Clear Signal Towers (New Kent County School Board): Clear Signal Towers, LLC and the New Kent County School Board have requested a conditional use permit for the purpose of installing a cell tower. Pursuant to Section 98-62 of the New Kent County Code, the "Communications Facility Tower - Radio, Cellular > 200 feet" use is allowed with a conditional use permit under the A-1, Agricultural zoning classification. The proposed site is located at 6501 New Kent Highway (Rt. 249), behind Watkins Elementary School. The property is identified on the New Kent County tax map as

parcel number 21-51A, and the digital map as GPIN L11-3588-0894. The property is designated as Rural Lands on the Comprehensive Plan's Vision 2020 Future Land Use Map.

- C. CUP-06-10, National Communication Towers (Moore): National Communication Towers, LLC and R. Wade & Kathleen Moore have requested a conditional use permit for the purpose of installing a cell tower. Pursuant to Section 98-62 of the New Kent County Code, the "Communications Facility Tower - Radio, Cellular < 200 feet" use is allowed with a conditional use permit under the A-1, Agricultural zoning classification. The proposed site is located approximately 1,000' northeast of the terminus of Topeka Road. The property is identified on the New Kent County tax map as parcel number 20-14-12, and the digital map as GPIN M09-2203-1349. The property is designated as Rural Lands on the Comprehensive Plan's Vision 2020 Future Land Use Map.
