Mr. Bill Lindsay brought to the Board's attention the letters received from the County and letters he sent to the County. He does not want pipeline, pump station or reservoir.

Ms. Patricia Townsend referred to the letters also; she requested the Board to review this matter; also she requested an itemized spending statement from the County Administrator's Office and from all other County offices. She had several other concerns and requested that a Water Board Control be started with a representative from each district. She also requested that a long-term development plan be made public.

Mr. Townsend asked what authority had Mr. Hart to exercise the right of eminent domain, when and by whom was it approved; also who is paying for the study, what other jurisdictions are involved, etc.

Ms. Cindy Carr, a resident of Minitree Glen Subdivision, said she felt discriminated against because she was the only one paying for water usage; she asked how the County can charge her for water when it does not own the system. Finally, she promised that she will pursue legal action if she does not get a satisfactory answer.

Ms. Ginny Morrow was angered by the letters. She opposes the reservoir project because it affects her homeplace, her home and her church. She referred to the public document entitled "Raw Water Study Group, Lower Virginia Peninsula, February 1994."

Mr. Tom Davis inquired as to the elimination of the dumpster site at Lanexa; he opposed the closing of that site.

Ms. Gwen Weber, though not affected by the reservoir, agreed with everything said by the opponents.

Mr. William Weber said that Malcolm Pirnie had entered their property without permission last year, but that he had cooperated with them this year; however, the letters were arrogant and disgusting to him because they asked permission for a four-year blanket permit.

Mr. Burrell spoke to the audience to acknowledge that the Board is aware of the citizens' concerns and will address them.
