- Applicants are required to notify the Commissioner of Revenue's office of any change in marital status.
- For qualified applicants, ten (10) acres and an amount up to the previous year's average assessed value for single family homes in the locality will be exempted for the tax year. **The average assessed value of dwellings for New Kent County in the tax year of 2018 was \$196,160.**

REQUIRED DOCUMENTATION

- Certificate of Marriage
- Death Certificate
- **For the surviving spouse of members of the armed forces killed in action**, certification from the Unlisted States Department of Defense, or successor agency, indicating the date that the member of the armed forces of the United States was killed in action.
- **For the surviving spouse of certain persons killed in the line of duty**, determination from the Comptroller prior to July 1, 2017 or the Virginia Retirement System, on or after July 1, 2017
