### DEFINITIONS

- GROSS RECEIPTS:** The whole, entire, total receipts, without deduction, except as provided by law. For the purpose of this license is based on the calendar year, January 1 through December 31.
- CONTRACTOR:** Code of Virginia § 54.1-1100, a "Contractor" is any person, that for a fixed price, commission, fee or percentage undertakes to bid upon, or accepts, or offers to accept, orders or contracts for performing, managing, or superintending in whole or in part, the construction, removal, repair or improvement of any building or structure permanently annexed to real property owned, controlled, or leased by him or another person or any other improvements to such real property... "improvement" shall include (i) remediation, cleanup, or containment of premises to remove contaminants or (ii) site work necessary to make certain real property usable for human occupancy according to the guidelines established pursuant to § 32.1-11.7.
- HANDYMAN:** is not licensed by the Virginia Board for Contractors. Cannot obtain building permits, accept over \$1,000 for any single project, perform electrical, plumbing, irrigation or HVAC work or use a trade name that suggests performance thereof. **Handyman affidavit required.**
- RETAIL SALE:** Sale of goods, wares and merchandise for use or consumption by purchaser for any purpose other than resale by the purchaser, but does not include sales at wholesale to institutional, commercial and industrial users which are classified as wholesale sales.
- WHOLESALE:** Sale of goods, wares and merchandise for resale by the purchaser, including sales when the goods, wares or merchandise will be incorporated into goods for sale, and also includes sales to institutional, commercial, industrial and governmental users which because of the facts and circumstances surrounding the sales, such as quantity, price or other terms, indicate that they are consistent with the sales at wholesale.
- SERVICE:** Things purchased by a customer which do not have physical characteristics, or which are not goods, wares, or merchandise. Child care is classified as a service. However, they must declare.
- FINANCIAL SERVICE:** The buying, selling, handling, managing, and investing regarding money, credit, securities or other investments for others as well as providing advice to others on such matters.
- REAL ESTATE SERVICE:** Providing a service for others with respect to the purchase, sale, lease, rental or appraisal of real property.
- PROFESSIONAL SERVICE:** The service performed by architects, attorneys-at-law, certified public accountants, dentists, engineers, land surveyors, surgeons, veterinarians, and practitioners of the healing arts (the arts and sciences dealing with the prevention, diagnosis, treatment and cure or alleviation of human physical or mental ailments, conditions, diseases, pain or infirmities) and such occupation as listed in the BPOL guidelines. The word "profession" implies attainments in the professional knowledge as distinguished from mere skill, and the application of knowledge to use for others rather than for personal profit.
